I. AWARD OF SILVER STAR. Under the provisions of AR 600-45 and Circular 6, Third U.S. Army, cs, the Silver Star is awarded to the following named officers for gallantry in action in northern France:

IT COL D.KENNETH REIMERS, 0271586, Field Artillery, United States Army. On 8 August 1944 Lt Col Reimers showed aggressive leadership and gallant action in giving close support to a fast moving column driving on * * France. At * * France on 8 August 1944 he went forward personally under enemy fire, kept his Battalion displacing by batteries, personally reconnoitered forward positions and sought forward observation. His aggressive and courageous action resulted in rapidly pushing back the enemy, destroying their positions and numerous armored vehicles supporting the defenses, and the ultimate capture of some 12,000 of the enemy troops. Entered service from Wyoming.

MAJ JOHN H. MASON, 0345436, Infantry, United States Army. On 8 August 1944 between * * and * * France, Maj Mason organized and personally directed under enemy fire a number of successful attacks composing Infantry, Artillery, Air and supporting tanks. Maj Mason's action resulted in fighting eight separate skirmishes completed in eight hours and an advance of some twenty miles from * * to * *. His disregard for personal danger, his aggressive leadership and coolness under fire was an inspiration to his command and in keeping with the highest traditions of the military spirit. Entered service from California.

II. AWARD OF OAK-LEAF CLUSTER TO BRONZE STAR.

Under the provisions of AR 600-45 and Circular 6, Third United States Army, cs, in addition to the Bronze Star previously awarded, an Oak-Leaf Cluster is awarded to CAPT JOHN S. FISK, 0413891, Infantry, United States Army. For meritorious service during the period 17 July 1944 to 25 August 1944 in action against an enemy of the United States in France. Entered service from Oregon.

Sgt Charles R. Bathurst, 33479055, Infantry, United States Army. On 26 July 1944 in the vicinity of the * * River, north of * * France, when his company had succeeded in reaching its objective it had sustained extremely heavy losses and had been pinned down to its position due to heavy enemy fire and tank attack. The heavy fighting had caused the loss of much equipment and it was necessary to gather up some of the equipment of the wounded and lost materiel in order to maintain the position. Sgt Bathurst and one companion, without regard to their own personal safety and under continuous enemy fire worked from place to place giving aid to the wounded and gathering up much needed weapons and ammunition, including the company's radio, two light machine guns and a bazooka, thus enabling the company to hold its position. His gallant act was in keeping with the highest traditions of the military service. Entered service from Pennsylvania.
